RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

**Warning! This is an important document which affects your legal rights and obligations.
Read it carefully and do not sign it unless you are satisfied you understand it.**

In consideration of being permitted to train, compete, observe, work for, or participate in any way with Ozswoosh or its associated clinics, camps, academy, trainings, education courses or any other Ozswoosh event herein referred to as "Ozswoosh Event(s)", **each of the undersigned**, for himself/herself, their personal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that they have or will immediately upon entering the Ozswoosh Event(s) facility/venue inspect the event venue, surface and surrounding area and if at any time, feels anything to be unsafe, will immediately advise those supervising the Ozswoosh Event(s) and will leave the training venue, surface or area and/or refuse to participate further, until they deem the venue, surface and surrounding area to be safe.

2. **Hereby releases, waives, discharges and covenants not to sue** the supervisors, coaches, promoters, participants, owners, sponsors, advertisers, lessees of premises used to conduct the Ozswoosh Event(s) in addition to underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or Ozswoosh Event(s) and each of their directors, officers, agents and employees, all for the purposes herein referred to as "Releasees," **from all liability, to the undersigned**, his/her personal representatives, assigns, heirs, and next of kin **for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned arising out of or related to the Ozswoosh Event(s), whether caused by the negligence of the Releasees or otherwise.**

3. **Hereby agrees to indemnify and save and hold harmless the Releasees** and each of them **from any loss, liability, damage, or cost** they may incur arising out of or related to the **Ozswoosh Event(s) whether caused by the negligence of the Releasees or otherwise.**

4. **Hereby assumes full responsibility for any risk of bodily injury, death or property damage** arising out of or related to the Ozswoosh Event(s) **whether caused by the negligence of releasees or otherwise.**

5. **Hereby acknowledges that Ozswoosh Event(s) and Basketball can be dangerous** and involve the risk of serious injury and/or death and/or property damage. Each of the **undersigned** also expressly **acknowledges that injuries received may be compounded or increased by negligent first response or rescue operations or procedures of the releasees.**

6. **Hereby agrees** that this *Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement* extends to all acts of negligence by the Releasees, **including negligent first response or rescue operations** and is intended to be as broad and inclusive as is permitted by the laws of the Province of State in which the Ozswoosh Event(s) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

7. **Hereby releases and agrees** to waive my confidentiality rights during any Ozswoosh Event(s) where the Medical Services are required to give to any party, details of my injury(s) for the purpose of reporting to higher authorities and insurance companies.

I have read this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without inducement, assurance or guarantee being made to me and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
